INITIAL CONSIDERATIONS

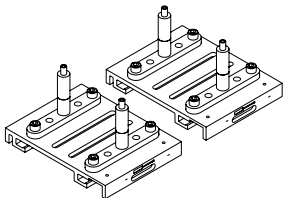
Plan your installation. Determine the length of your cassette and the centerline of your viewing area to make sure that you can install the brackets 2"- 8" from the end of the cassette.

Standard kits come with 2 Solo 3 - 575/675 Flown Kit Bracket assemblies. Each bracket can hold 50 lbs safely. For screens over 100 lbs, a third bracket is required.

As ceiling materials vary, screws for fixing to ceiling are not included. For guidance on appropriate screw systems, please consult your nearby specialized dealer.

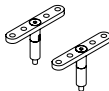
- 1** (2) Solo 3 Flown Kit

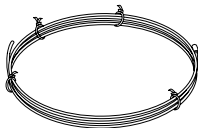
- 3** (2) Solo 3 Flown Kit

- 4** Hex key



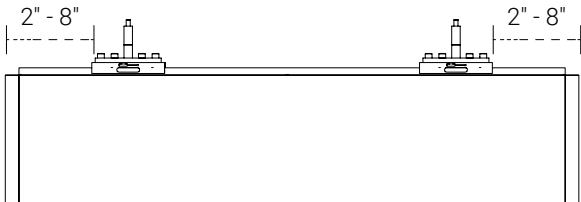

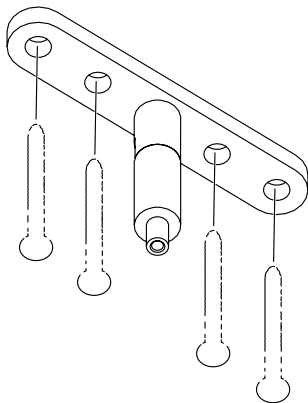
Parts in the Box

INSTALLATION

- Determine the desired viewing area with vertical centerline of the projected viewing area.
- The Solo 3 Flown Kit Brackets must be installed 2" - 8" from each end of the cassette. Measure the overall length of the cassette to determine the min. and max. horizontal spacing of the mounts. Mark the location of the desired location of the brackets.



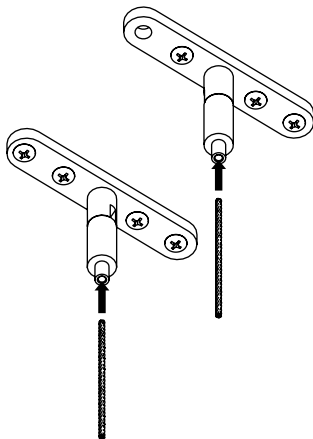
